Registration: Pre-register by mail, post marked no later than Saturday, June 23 2007. Race Day registration begins at 7:00 a.m. at the Community Center at the corner of North Jackson and Lee Avenue. Contact City Hall at 601-892-1210 for more information.

Directions: Take I-55 S. from Jackson to Crystal Springs/ Georgetown Exit 72. Take a left heading South on Hwy 27. At the 4-way stop turn right on Hwy 51 S. Go 1 mile & take a left on N. Pat Harrison Drive. Look for church parking lot on the right (about 1.5 miles).

Start/Finish line: Race will begin and end at the Community Center at the corner of North Jackson and Lee Avenue.

Cost: \$12.00 pre-registered \$15.00 on race day

Awards & Age Groups: Award ceremony to be held immediately after the Fun Run. A male/female winner in the overall, masters (40+), grand masters (50+) will be awarded. Also, 1st, 2nd, and 3rd places in the following age groups will be awarded:

- **5K Run (female)** 18 & under: 19-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50 & over
- **5K Run (male)** 18 & under: same as above with added categories of 50-54, 55-59, 60-64, 65-69, and 70+
- **5K Walk:** 0-19, 20-29, 30-39, 40-49, 50-59, 60-69, 70+
- **1 Mile Fun Run:** Trophies awarded to overall male & female winners and 1st, 2nd and 3rd places in these age groups: 0-5, 6-7, 8-9, 10-11, 12-13, 14-15
