What: 5K run/walk and 1-mile Fun Run

Where: Registration and Race begins & ends in front of the Activities Building at First Baptist Church Clinton.

Course: Course is primarily run on the brick streets in Old Town Clinton.

Entry Fee: 5K Run/Walk -\$20 for registrations postmarked before July 11/\$25 after July 11. Entries include a Brooks moisture transfer running shirt. (Sizes not guaranteed for late entrants.)

1-Mile Fun Run - \$5 (does not include Brooks shirt)
Family Maximum of \$60 (Must be in same household.)

Age Groups:

5K run: Overall male and female winners, Masters (40+), Grand Masters (50+) and 1st in each age group will be awarded prizes.

5K Run Age groups are: 10 & under, 11-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69 and 70+.


5K Walk: Overall male and female winners, Masters (40+), Grand Masters (50+) and 1st in each age group will be awarded prizes.

5K Walk Age groups are: 19 & under, 20-29, 30-39, 40-49, 50-59, 60-69 and 70+.

1-Mile Fun Run: Ribbons will be awarded to all participants. Overall male and female and 1st in each age group will be awarded prizes. Age groups are: 0-5, 6-7, 8-9, 10-12 (for ages 12 & under only).
